BOOKING CONDITIONS

Reservations for Saltwater, however made, are subject to the following conditions:

The contract for the rental of the property is between you (the hirer) and us (the owner) and is made on the understanding that the property is to be used for holiday purposes only and all conditions shall be governed by English law and jurisdiction. We cannot accept bookings from persons under the age of 18.

Rental Deposit

A deposit of 20% of the total rental is required to secure reservations. Full payment is due if the reservation is made within six weeks of your holiday. There are no booking fees. We welcome all major debit/credit cards with no additional charges, the transaction will appear on your card statement in the name '**Morco**'.

Balance Payment

The balance is due six weeks before your holiday begins and again can be paid for with any major card. We will charge the same card used for your deposit **unless** you advise us otherwise. If the balance cannot be authorised and is not received by this time we reserve the right to cancel the reservation and the deposit will be non-returnable.

Security Deposit

A deposit payment of **£100** is due with your balance and this will be charged to your debit/credit card accordingly. Should there be no claim, this deposit will be refunded after your departure. You and your party are responsible for the reasonable care of the property and contents. **All or part of this deposit may be taken if the property is not left in a clean and tidy condition or there is damage to the property or contents.** We further reserve the right to demand payment in excess of this amount should the cost be in excess of £100 and to repossess the property if required. Please be aware that we maintain a detailed inventory of every item in the property. **Your deposit will be affected if you fail to make the refuse bins available for emptying if you are at the property on a Monday/Tuesday, also if the barbecue is not left in a clean condition after use.**

Cancellation / Curtailment

If you need to cancel your reservation you must advise us immediately. You will remain liable for full payment unless we are able to re-let. You are advised to arrange insurance cover in the event that you need to cancel or curtail your holiday.
